Victoria Native Friendship Centre welcomes Indigenous families, elders, and individuals, to a place to call home in a safe and healthy community complex. Fernwood House has eight 2bedroom units. Siem Lelum has forty-one suites, ranging from studios to 3-bedroom units. Salish Sea House has twenty-eight units ranging from 2-bedroom units to 3-bedroom units, and one accessible unit. The household income must not exceed the Housing Income Limits (HILS) and must meet affordability standards. You must keep your application active by phone or email at a minimum every 3 months.

Two Bedrooms	\$65,000
Three Bedrooms	\$82,000

## **Important Guidelines**

- No pets allowed on any of our properties.
- No drugs or smoking of any combustibles allowed on the premises at any time. No alcohol consumption in any common areas and no parties that will disturb the quiet enjoyment of other tenants.
- All adults in the household must complete the Renting it Right program (all three minicourses). Certificates must be attached to the application to be accepted.

VNFC Properties must adhere to the **National Occupancy Standards** when considering a household composition for units. These guidelines are:

- There shall be no more than 2 or less than 1 person per bedroom.
- Spouses and couples share a bedroom.
- Parents do not share a bedroom with children.
- Dependents aged 18 or more do not share a bedroom.
- Dependents aged 5 or more of opposite sex do not share a bedroom.
- In recognition of a variety of co-parenting arrangements, a dependent child who resides with their parent(s) a minimum of 40 percent of the time will qualify as a permanent member of the household when determining eligibility and appropriate unit size.
